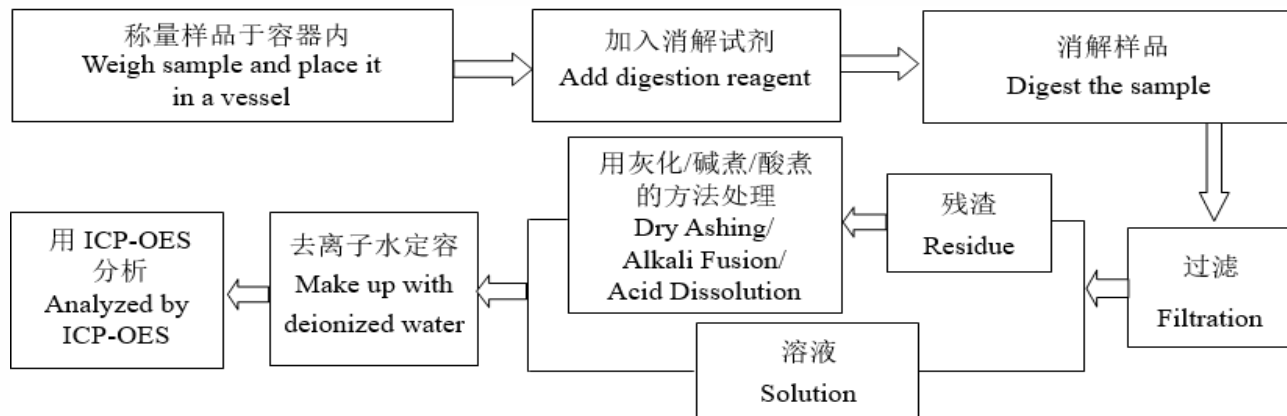

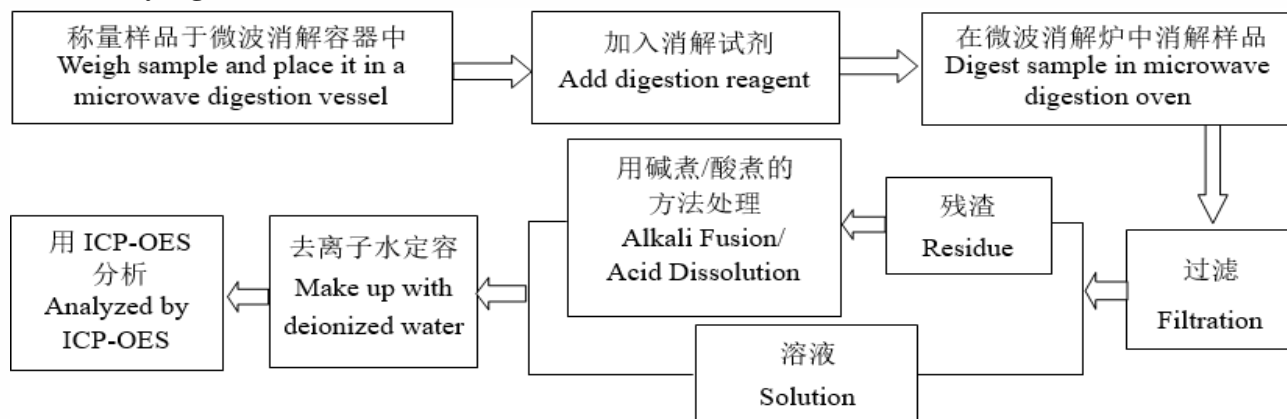

#### Lead(Pb), Cadmium(Cd), Chromium(Cr)



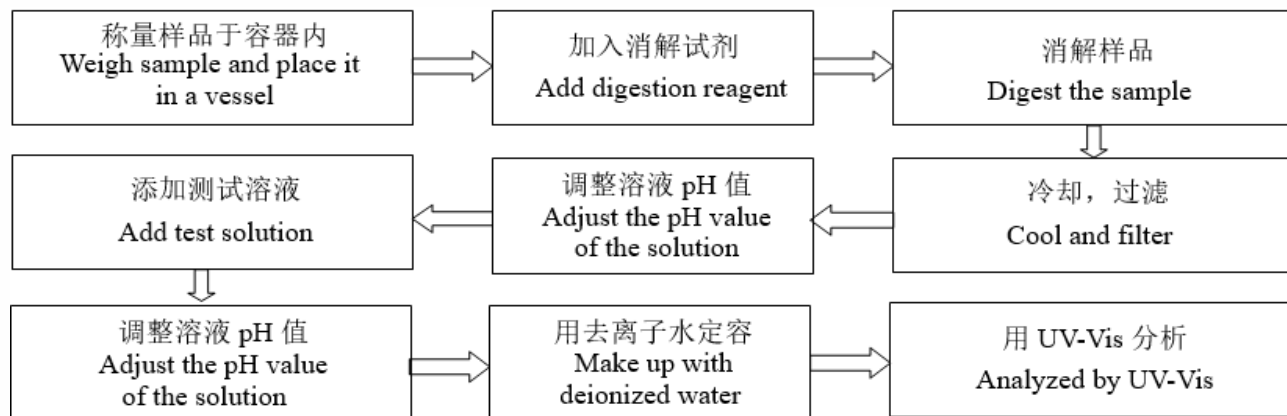

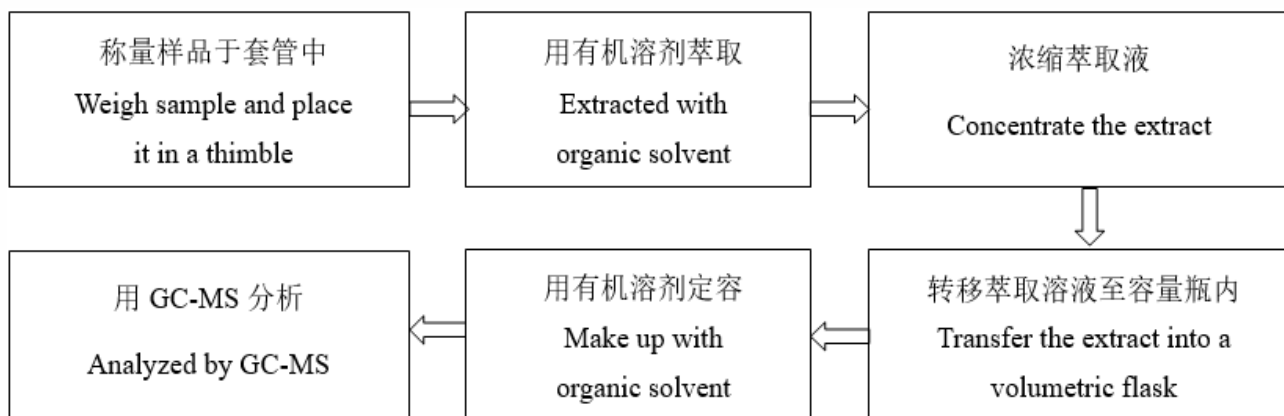

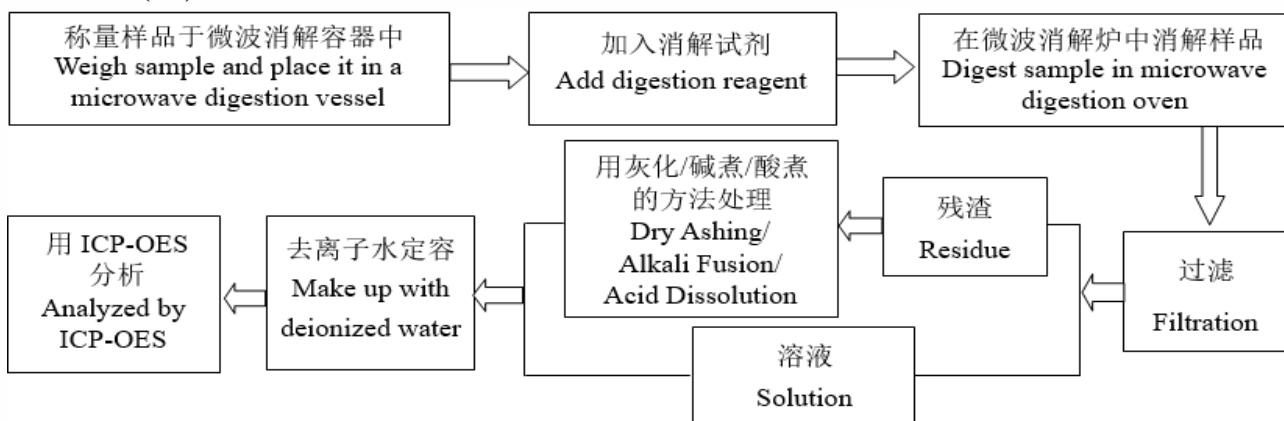
